HOUSING OPTIONS

Dormitories

1. Bunk House Dorms Rent: \$250/person/month (two-bed small room); \$275/person/month (two-bed large room)
2. Corporate Building Dorms Rent: \$250/person/month (three-bed room); \$300/person/month (two-bed room)
Dorms deposit: \$250/person

The Bunk House and Corporate Building offer furnished dormitory-style living accommodations. Each property has two or three-bed shared rooms (twin size beds), a communal living area, dining area (no stove/oven), men’s and women’s restrooms/showers and a coin-operated laundry facility. All utilities, plus wifi and cable television, are included in the cost of rent.

Riverside Housing

Two-bed and three-bed room shared room rent: \$300/person/month
Riverside deposit: \$250/person

The Riverside housing property consists of 2 apartment-style units. Each unit has two shared bedrooms, one bathroom, a kitchenette (no stove/oven), living area and dining area. There is a coin-op laundry facility (with additional restroom) attached to the building. All utilities, plus wifi, are included in the cost of rent.

Quads Housing Complex

1. Private bedroom rent: \$500/month
2. Shared bedroom (2 beds, bunk style) rent: \$300/person/month
Quads deposit: \$250/person

The Quads are four-bedroom, two-bathroom furnished apartments. Each unit has private bedrooms and/or two-bed shared rooms, shared bathrooms, kitchenette (no stove/oven) and living room. There is an on-site coin-operated laundry facility located in the building. All utilities, plus wifi and cable television (in the living room), are included in the cost of rent.

Condos

1. Private bedroom and bathroom in two-bedroom shared unit rent: \$500/bedroom/month
2. Two-bedroom family unit (entire condo) rent: \$1,100/month
3. One bedroom unit rent: \$800/month

Condos deposit: \$250 (private room in shared unit), \$1,100 (family) or \$800 (one bedroom)

The condos are one bedroom, one bathroom or two-bedroom, two-bathroom apartment units. The two-bedroom furnished units offer each tenant a private bedroom and bathroom with shared kitchen and living room. One bedroom units are unfurnished. There is an off-site coin-operated laundry facility located nearby. All utilities, except for wifi and cable television, are included in the cost of rent.

- Placement in employee housing is not guaranteed. If we are unable to accommodate your housing request, you will be referred to the “other housing options” tab on the Shore Lodge Housing website.
- New tenants must pay first month’s rent plus deposit at the time of move-in (or a minimum of the deposit). **Cash, checks and credit/debit cards are accepted.** Subsequent rent payments are automatically deducted from employee paychecks twice per month.
- In shared living or roommate situations, males will be placed with males and females will be placed with females. Roommate requests will be given consideration, but not guaranteed.
- **Bedding and towels** are not provided. **Pets and overnight guests** are not permitted in the Corporate Building Dorms, Bunk House Dorms, Quads or two-bedroom shared condos.
